




### TWL Shareholder Class Locality Map

  - o 28 Landowner companies



### The Evolution - Growing the Business : TWL Trucking (2009)






#### Trans Wonderland Limited (TWL) commenced operation on 12<sup>th</sup> June 2009



- In 2019, TWL successfully acquired 50% equity in PPL, expanding and deepening its logistics capabilities in marine logistics, freight forwarding, fuel distribution and management, vessel chartering and agency services, and oil spill response.
- The acquisition led to a restructure as TWL Group, and shortly thereafter, a rebrand as TWL Logistics to better represent its broadened capabilities.


# Western Province Gas Discovery



- Resource Volumes 2.29 TCF (Gas 2C) & 74.2 MMbbls (Cond 2C)
- Discovered resources for over 30years have sat undeveloped



# PDL 10 – Stanley Gas Development Project



#### **Base Development Plan**

- Development wells already drilled (x5 Wells), resource certified, Design Basis Memorandum, EPF Tender Basis
- PDL 10 Granted in 2014
- 140mmscfd gas recycle project initially producing up to 4000 bopd condensate
- Condensate Gas Recycle Project. Modular Gas Plant with singlestage separation and liquids stabilisation.

#### Small Scale LNG

- Small Scale LNG Facility to tie into Gas Plant. New Technologies now in the market allowing for modular Micro/Mini LNG setup.
- Close to road and river infrastructure for liquid truck and barging to market
- 18-24month construction period following a Financial Investment Decision (FID)



### Small Scale LNG Technology



#### Small Scale LNG Technology

- Matured Technology that has been used and is working in other parts of the world including US, Europe and China
- Modularised and Scalable
- Plug & Play Technology for optimisation of Start-up Capex and expansion of capabilities upon commercial growth and demand.
- Virtual Pipeline Solutions for compression, transportation of LNG and regasification.
