

GOLD BILL KILIM PNG!



Bai National Gold Corporation Bill i afektim ol sevis long PNG Entry Ports olsem wanem?

Papua New Guinea Ports (PNG Ports), Civil Aviation Authority (CASA) na National Airport Corporation (NAC) em ol gavman ejensi husat i mekim impoten wok bilong menesim ol bisnis operesen long ol ples balus na bris long Papua Niugini.

Hia em sampela imek bilong dispela bill long ol dispela ki institusen bilong gavman:

- a.** Daunim na/o mekim wankain wok bilong PNG Ports long wokim na reguletim ol bikpela bris, wof, dok na kain infrastraksa olsem, moa hap bilong putim na muvim ol gold prodak (**Section 208, Section 209, Section 210**).

208. STORAGE FACILITIES.

Without limiting Section 207, the National Mint may establish, operate and maintain storage and safekeeping facilities to international standards for gold, gold goods and gold products, and other valuable objects or things, in Papua New Guinea or any foreign country, including -

- (a) storage facilities, and warehouse and delivery facilities, at airports, or any other customs controlled border, port of entry or export, in Papua New Guinea or any foreign country; and
- (b) facilities and services to enable storage and delivery of gold, gold goods and gold products for import or export, whether for travellers, commercial or other customers, which, in the case of Papua New Guinea, has, where required, received Customs clearance, or, in any other place or foreign country, has received similar clearance.

- b.** Rausim pawa bilong CASA long lukautim operesen bilong ples balus, ol fasiliti na sekyuriti, akses long premises, na praivet sekyuriti arensmen we i wankain olsem wok CASA i mekim nau. (**Section 940**)

- c.** Bagarapim wok bilong National Airports Corporation long lukautim ol operesen bilong ples balus. Em i tok long Minista bilong Civil Aviation, Civil Aviation Authority na ol lain i lukautim ples balus long bihainim ol rul i stap long dispela bill, maski sapos i egensim Civil Aviation Act. (**Section 210, Section 939, na Section 940**).

210. CUSTOMS AUTHORISATIONS.

The Chief Commissioner of Customs shall, upon application by the National Mint, promptly grant and issue any licence or other authorisation required under the *Customs Act*, and without fee, permit the National Mint or National Gold, as the case may be, to -

- (a) establish, operate and maintain -
 - (i) the storage facilities, warehouse and delivery and facilities; and
 - (ii) retail shops, including outward duty free shops and inwards duty free shops; and
- (b) provide the facilities and services, prescribed in Sections 205, 207, 208 and 209 at airports, or any other Customs controlled location or order, port of entry or exit in Papua New Guinea.
